**Section I
Introduction**

1. Purpose

This pamphlet is a category of official NGB Forms and Posters.

2. Stock

Most forms are stocked at NGB-DMJ, Camp Keyes, Augusta, ME 04333-0032 and supplied to PDO's / Publications Officers for issue to users. Other forms must be ordered from the agency listed after the form.

- a. LRA (Local reproduction authorized) – do not alter design or size during the printing process.
- b. S&I (stocked and issued) – an office symbol to whom the user should make the request.
- c. S&U (stocked and used) – not issued to other activities.

3. Requisition

All requisitions for forms stocked and issued by NGB-DMJ will be submitted on an NGB Form 13-R-E. Emergency requisitions of forms will be made by calling DSN 476-4212 or Commercial 207-626-4212. Emergency requisitions will be limited to 25 copies unless otherwise justified.
