4. Requisitions

All requisitions must be submitted, through an account representative that supports your organization, by completing an NGB 13R, NGB Materials Requisition Sheet. Exceptions are listed below. Emergency requisitions will be made by calling DSN 626-4212 or Com 207-626-4212. Emergency requisitions will be limited to 25 copies unless otherwise justified.

- a. S&I (stocked and issued) - an office symbol to whom the user should make the request.
- b. S&U (stocked and used) - not issued to other activities.

5. Forms Management

Forms are the responsibility of the proponent agency. All forms must be coordinated on by the proponent agency and submitted for approval by the Forms Manager prior to implementation. Forms will not be approved for printing, reproduction, or electronic distribution unless their use is prescribed by an agency or command publication and be coordinated with the designated functional manager before it is issued. If a prescribing publication is rescinded or expires, the forms prescribed by the publication are automatically rescinded.
